- 1. **Bill of Lading deletion status after CBP Release** = The Trade has commented they get a Bill of Lading deletion status in the Manifest status after cargo release. This has been happening for some time now. The carriers state they are not deleting their manifests. Does CBP know why is this happening? Is this an ACE glitch?
- 2. **CBP Hold placed after release.** A Formal Entry with CBP release 1USG is placed on hold hours <u>after</u> release. Can CBP explain the reasons as to why this happens after it has been released? If possible, can CBP review the Entry with documents instead of requesting redelivery?
- 3. **Perishables with Conditional Release:** During a CBP downtime, would it be possible to designate perishable commodities to be examined regardless if targeted for intensive exam, or not, so that when the system goes up, perishables do not need to be returned?
