- **Cancellation of Entry** Need clarification of what is the correct process. Is a letter required or is the request done electronically? Requirement has been inconsistent.
- 3) Hazmat Pre-Notification cancellation requirement Trade Bulletin
 - a. Does this mean 3461/MSDS packets are no longer required to be emailed to colmet@cbp.dhs.gov?
 - b. Does this mean the freight can cross as soon as it can? (No more 24/6 hour wait)?
 - c. If the above is correct, can CBP provide an updated HAZMAT CHECKLIST version? The current Checklist requires 24-hour packet prior to import.
- 4) CBP Badge Issuance procedures post pandemic:
 - a. Is there a grace period for expired badges to be valid for since many were not renewed during pandemic?
 - b. Please confirm if there are different requirements that apply for:
